**Tuition payments are made in ten or eleven monthly payments beginning July 1 or August.** The July and August payments are not refundable and are nontransferable.

Tuition payments are considered late after the tenth of each month. A \$30 fee will be added whenever there is an outstanding balance after the tenth of the month.

A \$25 fee will be charged for any returned checks. Only cash, money order, or certified check will be accepted if more than two (2) checks are returned during the year.

If the tuition account becomes thirty days in arrears, parents will be asked to withdraw their child until payment is made.

No monthly tuition will be refunded for students withdrawn or dismissed after the fifteenth of any month. The maximum amount of monthly tuition to be refunded will not exceed one half of the monthly total.
